The programme

Practical information

- 2-year Master programme
- Bilingual programme, courses are delivered in English and French
 - active knowledge required only for one
- Lectures are organised over 4 weekends per semester in Luxembourg, and will be broadcast online via video conference
 - Friday afternoon to Sunday noon
- Master thesis concludes the programme
- Diploma (Master II) will be awarded by the Université de Lorraine

Innovative methodology

The programme is based on a combination of a number of teaching methodologies:

- Students attend face-to-face lectures, which will be broadcast online via video conference for students abroad, using interactive education methods
- A set of online learning tools such as video tutorials (asynchronous), webinars, assignments and online tests are offered
- Students are invited to engage in guided distance learning

Who can apply?

Any candidate with:

- A Bachelor's degree or an equivalent educational level (in law, political science, economics, European studies or other fields)
- An active knowledge of English or French, with at least a passive knowledge of the other language



First academic year

- European integration process and its history
- Constitutional European law - EU legal system, institutional law, decision-making processes and system of judicial remedies
- EU substantive law - the four freedoms and competition law
- Policies related to the internal market - EMU, company and tax law, public procurement
- Current challenges and future prospects of the EU

Second academic year

- Implementation of EU law at European and national levels - EU administrative law, including the system of implementing and delegated acts
- Other policies related to single market - environmental law, intellectual property, electronic communications and social and labour law
- Human rights protection in Europe
- Area of Freedom Security and Justice
- Role of the EU as an international actor
